2. Show Sponsor reserves the right to control the use of any volume of any loudspeaker, radio, musical instrument or any noise-making device that might interfere with Exhibitors in the immediate area. Public address systems cannot be used except by special permission.
3. Show Sponsor will use all reasonable care to prevent loss or damage to Exhibitor's property, but is not liable in any manner for such loss.
4. Show Sponsor reserves the right to move any Exhibitor. Exhibitors will be notified before being moved.
5. The Exhibitor agrees to hold Show Sponsor and all co-sponsoring organizations harmless and blameless and assume all liability for bodily injury of property damage to employees or patrons.
6. CANCELLATION: If the Exhibitor has paid fees in full and for some reason is not able to exhibit at the herein mentioned Show, the Exhibitor will be refunded full space fees, if he notified the Show Sponsor thirty (30) calendar days prior to the Show.
7. Photos will be taken throughout the event and images may be used in marketing materials for print, web and social media.
