 3. Helium balloons may be distributed, BUT if they float to the ceiling, the Exhibitor is responsible for the cost of removal.
 4. Nothing may be taped to the walls or floors of the facility.
 5. Popcorn machines, diffusers, and microwaves CANNOT be used by Exhibitors.
 6. Show Sponsor reserves the right to control the use of any volume of any loudspeaker, radio, musical instrument or any noise-making device that might interfere with Exhibitors in the immediate area.
 7. Show Sponsor will use all reasonable care to prevent loss or damage to Exhibitor's property but is not liable in any manner for such loss.
 8. An opportunity to connect to electrical will be provided. It is the responsibility of the Exhibitor to bring extension cords if needed.
 9. Show Sponsor reserves the right to move any Exhibitor.
 10. The Exhibitor agrees to hold Show Sponsor and all co-sponsoring organizations harmless and blameless and assume all liability for bodily injury or property damage to employees or patrons. In order to do this, Exhibitor must show evidence of liability insurance.
